In both Canada and its operations in Cambodia, working from different ends of the development spectrum, Angkor Gold will be part of developing testing and implementing a model blueprint for promoting gender equality in ethical business development. Angkor Gold’s management sees this as an opportunity to take best practices from across Canada and implement them in both an emerging market and Canada’s developed sector.

Delayne Weeks, Angkor’s VP of Social Development, said, “We have a great opportunity to learn and grow when we share the weaknesses and strengths of various private-sector companies and commit to improving ourselves and our companies. Gender equality is challenging in the most developed nations. Undertaking this in Cambodia in a new industry sector such as mining makes it even more challenging, but nonetheless a worthy exercise. This is part of making our countries better, and appreciating that we have the choice to do so in Canada.”
